THE CHATTERLEIGH ASSOCIATION, INC.

Constitution approved at general meeting of the Association on May 17, 2023

History: The CAI Constitution was originally adopted on 6/13/1963, and subsequently amended on 1/1/1986, 5/20/2003, 5/19/2009, and 9/21/2010

CONSTITUTION

ARTICLE I. Name, address and purpose

Section 1. Name and address:

The Chatterleigh Association, Inc. Towson, Maryland 21286

Section 2.

The Chatterleigh Association, Inc. (herein the "Association") shall be a non-profit organization. Its purpose shall be to promote the communal good; better individual relationships between neighbors; to actively participate in Civic affairs; to cooperate with neighboring organizations; to act as a source of collective action relative to affairs and events concerning the betterment of the community. The Association is to be non-political and non-sectarian.

ARTICLE II. Board of Governors

- **Section 1.** The Board of Governors shall be the final authority in the interpretation of the provisions of this Constitution and the By-Laws to follow.
- **Section 2.** The Board of Governors shall consist of:
 - a. The six (6) officers of the Association.
 - b. The six (6) Board members at large elected by the Association.
 - c. The immediate Past President of the Association, who shall serve for one year.
 - d. All Committee Chairpersons.
- **Section 3.** The following restrictions apply to positions on the Board of Governors:
 - a. Officers and Board Members at Large may not share a household with any other Officer or Board Member at Large, nor may any individual hold more than one Officer or Board Member at Large position.
 - b. The immediate Past President and all Committee Chairpersons, and members of their households, may hold multiple positions on the Board of Governors, subject to the restriction in §II.3.a.

Code of Conduct – All Board Members shall uphold the purposes of the Association. Upon the finding of the Board of Governors that any Board Member has recklessly or flagrantly acted contrary to the purposes of the Association, such Board Member may be dismissed from the Board of Governors upon a 2/3 majority vote of the Board at any meeting in which a quorum is present, provided that all Board members shall be notified of the proposed action seven days in advance of such meeting.

ARTICLE III. Membership

- Shall be only those owners of the improvements set forth on the properties of lots belonging to Chatterleigh, Brook Meadows, Hunt Club Farms, Hunt Crest Estates and Brookview Farms, listed in Exhibit A (addresses of all Association properties).
- A membership shall include all persons in a member's immediate family and household, PROVIDED, HOWEVER, that each address of property within the Association is entitled to only one vote; each membership shall be counted as one in ascertaining the existence of a quorum at the annual meeting and any special meetings of the Association.
- **Section 3.** Membership in the Association may be terminated or suspended upon the occurrence of any of the following:
 - a. Upon written request of the member.
 - b. Upon failure to maintain good standing because of non-payment of dues or assessments within the time designated by the By-Laws.
 - c. Upon determination by the Board of Governors that any member has flagrantly or continuously acted contrary to the purposes of the Association or has deliberately violated the By-Laws, Constitution or Rules of this Association.
 - d. If he or she ceases to be a property owner in the Chatterleigh Association.
 - e. Termination or suspension does not release the property or owner(s) from complying with the restrictive covenants imposed on the property.

ARTICLE IV. Dues

Dues shall be on a yearly basis and payable by the Annual Meeting and ending on the date of the subsequent Annual Meeting (an "Annual Membership Period"). Any payment after the Annual Meeting shall confer Membership to the payor household until the date of the next Annual Meeting, unless such payment is specifically designated for the next Annual Membership Period. In the event that an Annual Meeting is not held in the month of May, then dues shall be payable by May 31 with such Membership remaining in force until the earlier of: the next Annual meeting held in the calendar year following the year of the dues payment or May 31 of the following year.

ARTICLE V. Officers and Elections

- **Section 1.** The officers shall consist of a President, Vice President, Treasurer, Recording Secretary, Corresponding Secretary and Sergeant-at-Arms.
- Section 2. No officer shall be elected to more than two consecutive terms for the same office, subject however to the provisions set forth in Section 9, except the Treasurer who may be elected for more than two consecutive terms.
- **Section 3.** No member shall be eligible for office or membership on the Board of Governors whose dues have not been fully paid according to Article IV, Section 1.
- **Section 4.** In addition, the immediate Past President of the Association shall serve as an Exofficio member of the Board of Governors; however, the term thereof shall be limited to one (1) year.
 - a. There shall be an Executive Committee consisting of the President, Vice President, Treasurer, and one member of the Board of Governors at Large appointed by the President of the Association and confirmed by the Board of Governors. Any three members thereof shall constitute a quorum.
 - b. The Executive Committee shall have authority to execute all powers of the Board of Governors between meetings of said Board. No action of the Executive Committee shall become operative unless it has the affirmative vote of at least three members of the Executive Committee. All Executive Committee decisions or recommendations will be reported to the Board of Governors within ten (10) days. Among their duties shall be that of imposing sanctions or removal of any member of the Board of Governors who fails to attend two (2) consecutive meetings without just cause.
 - c. Meetings of the Executive Committee may be called at any time by the President or by any two members of the Executive committee.
 - d. The Vice President of the Association shall act as secretary of the Executive Committee and shall keep regular minutes of the actions of said Committee and report the same to the Board of Governors, and the Board shall adopt such report as a part of its proceedings.
- **Section 5.** The President of the Association shall be Chairperson of the Board of Governors.
- **Section 6.** Members at large of the Board of Governors shall be limited to two (2) successive terms of two (2) years each, subject to the provisions of Section 9.
- Section 7. The term of any Board position shall run from the Annual Meeting to the Annual Meeting in the next calendar year; except for vacancies filled during a Board term, which shall commence on the date of such appointment and shall run until the next

Annual Meeting. Service for a partial year shall not count toward a term limit described in Article V.

- **Section 8.** Officers shall hold office for one (1) year and shall be eligible to be nominated for a second one-year term, subject to the provisions of Section 9.
- **Section 9.** All officer and Board of Governors vacancies during the year shall be filled by appointment by the Board of Governors to serve the balance of an unexpired term.
- **Section 10.** If the term of an officer or member of the Board of Governors has expired and no member is willing to replace him/her, then s/he may be nominated to serve another term.
- Section 11. There shall be at least two (2) meetings annually of the Board of Governors, which shall be called by the President of the Association.
- **Section 12.** Election of officers and at large members of the Board of Governors shall take place at the annual meeting of the Association.
- Section 13. All members in good standing shall be notified by the Corresponding Secretary of the names of the nominees at least fifteen (15) days in advance of the election meeting. If no nominations come forward by this time, nominations may be accepted from the floor at the annual meeting.
- Members may submit, by a letter to the President, the names of nominees. No later than 15 days prior to the Annual Meeting, the Executive Committee shall convene to develop a slate of nominees for all Board of Governors positions for the following Board term. Prior to publishing the slate, the Executive Committee shall confirm that each nominee accepts the nomination. In the event that more than one person is nominated for the same position, the Executive Committee shall attempt to reconcile the conflict via communication with the nominating Member(s) and nominee(s). The Executive Committee shall have the discretion to develop a final slate for presentation at the Annual Meeting. Such slate shall be initially proposed for consideration of the Membership at the Annual Meeting and will require a Motion and Second from Members not serving on the Executive Committee to be considered for endorsement. If Members decline to endorse the slate offered by the Executive Committee, then any Member may move an alternate slate.
- Section 15. The President, with the consent of a majority of the Executive Committee, shall establish or dissolve committees as deemed useful for advancing the purposes of the Association. Committees may be chaired by any Board member; however, such person shall only be entitled to one vote.
- Section 16. Committee Chairpersons shall be nominated by the Executive Committee and approved by a majority of the Board. Committee Chairpersons shall have the same rights and obligations of an at large Board member. However, if the Committee is dissolved then appointment as Chair of said committee will no longer confer Board membership.

ARTICLE VI. Amendments to the Constitution

Section 1. This Constitution may be amended at any meeting of the Association by vote of two-thirds (2/3) of the members present and in good standing.

Section 2. Proposed amendments shall be submitted in writing by any member in good standing to the Board of Governors. After approval by a majority of the Board members, the proposed amendment will be considered for adoption at the next annual meeting of the Association.

ARTICLE VII. Amendments to the By-Laws

Section 1. Amendments to the By-Laws shall require a simple majority of votes to be cast by members present and in good standing at an annual meeting of the Association.

ARTICLE VIII. Fiscal Year

Section 1. The fiscal year of the Association shall commence on June 1st of each year.
